

RESOLUTION NO. 15-38

A RESOLUTION APPOINTING MEMBERS AND ALTERNATE MEMBERS TO THE DRAPER CITY EQUESTRIAN CENTER ADVISORY BOARD

WHEREAS, the Draper City Council has adopted Ordinances which provide for the appointment of members to the Draper City Equestrian Center Advisory Board; and

WHEREAS, members of the Draper City Equestrian Center Advisory Board are appointed by the Mayor with the advice and consent of the City Council; and

WHEREAS, terms of office are set to be four-year terms with some terms being two-year when necessary to provide for staggered terms; and

WHEREAS, these individuals have expressed an interest in serving on the Draper City Equestrian Center Advisory Board and have been interviewed by the Mayor; and

WHEREAS, the Mayor proposes to appoint Doug Vawdrey, Julie Openshaw, Walter Roseman, Kenneth Day, Julie Stephenson, Janice Klein, Katie Ovard-Smith, Maureen McDonald, Alan Kirton, and Zachary Watson to serve as members of the Draper City Equestrian Center Advisory Board.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF DRAPER CITY, STATE OF UTAH, AS FOLLOWS:

The City Council hereby provides its advice and consent to the Mayor's appointment of Doug Vawdrey, Julie Openshaw, Walter Roseman, Kenneth Day, Julie Stephenson, Janice Klein, Katie Ovard-Smith, Maureen McDonald, Alan Kirton, and Zachary Watson to serve as members of the Draper City Equestrian Center Advisory Board.

Section 1. Appointment. The following individuals are hereby appointed to fill the terms listed below as members of the Draper City Equestrian Center Advisory Board according to the laws, ordinances and regulations governing the Draper City Equestrian Center Advisory Board and its members for the term specified herein.

Four-year terms:

Maureen McDonald	July 7, 2015 through June 30, 2017
Alan Kirton	July 7, 2015 through June 30, 2017

Alternate Members:

Zachary Watson

July 7, 2015 through June 30, 2019

Section 2. Severability. If any section, part of provision of this Resolution is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Resolution, and all sections, parts and provisions of this Resolution shall be severable.

Section 3. Effective Date. This Resolution shall become effective immediately upon its passage.


