

ORDINANCE NO. 1162

AN ORDINANCE AMENDING CHAPTER 3 OF THE DRAPER CITY MUNICIPAL CODE RELATING TO THE RECREATION DEPARTMENT

WHEREAS, the Draper City Council recently added the Parks Department responsibilities to those of the Recreation Director; and

WHEREAS, the Draper City Council desires to amend Sections 3-1-066 and 3-1-067 to incorporate those changes.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF DRAPER CITY, STATE OF UTAH, AS FOLLOWS:

Section 1. Amendment. Section 3-1-066 and Section 3-1-067 of the Draper City Municipal Code are hereby amended to read in their entirety as set forth in Exhibit "A" attached hereto and incorporated herein by this reference with all other chapters of the Draper City Municipal Code to remain in full effect.

Section 2. Severability. If any section, part or provision of this Ordinance is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Ordinance, and all sections, parts and provisions of this Ordinance shall be severable.

Section 3. Effective Date. This Ordinance shall become effective upon recording by the City Recorder, and 20 days after publication or posting or 30 days after final passage by the City Council, whichever is sooner.

Section 3-1-066 Parks and Recreation Department. There is hereby created and established a Parks and Recreation Department. The Parks and Recreation Department shall be responsible for the planning, development and delivery of a comprehensive public recreation program for the city. The Parks and Recreation Department also oversees the operations of the City's Amphitheater, the City's parks and trails, and other functions as deemed appropriate by the City Council and City Manager.

Section 3-1-067 Parks and Recreation Director. There is hereby created the position of Parks and Recreation Director who shall act as the Department Head of the Parks and Recreation Department. The Parks and Recreation Director shall have such powers and duties as designated by the City Manager. The Parks and Recreation Director is appointed by the Mayor with the consent of the City Council.
