RESOLUTION OF DRAPER CITY APPROVING AND  
AUTHORIZING EXECUTION OF AN INTERLOCAL  
AGREEMENT BETWEEN DRAPER CITY AND THE  
REDEVELOPMENT AGENCY OF DRAPER CITY

**WHEREAS**, after careful analysis and consideration of relevant information, DRAPER CITY (the “**City**”) and the REDEVELOPMENT AGENCY OF DRAPER CITY (the “**Agency**”) desire to approve and enter into the Interlocal Agreement attached hereto as Exhibit “A,” whereby the City consents to the Agency receiving certain property tax increment from the Draper FrontRunner Community Development Project Area (the “**Project Area**”) attributable to the City’s tax levy and that such tax increment be used to fund the Project Area and the Draper FrontRunner Community Development Project Area Plan (the “**Plan**”); and

**WHEREAS**, Section 11-13-202.5, Utah Code Annotated 1953, as amended, requires certain interlocal agreements be approved by resolution or ordinance of the legislative body, governing board, council or other governing body of a public agency.

**NOW, THEREFORE, IT IS HEREBY RESOLVED BY DRAPER CITY** as follows:

1. The Interlocal Agreement between the **City** and the Agency attached hereto is approved and shall be executed by the **City** by signature of the appropriate person(s).
2. The Interlocal Agreement shall be effective immediately upon execution and shall have an effective date of December 31, 2012.
3. Pursuant to Section 11-13-202.5, Utah Code Annotated, 1953 as amended, the Interlocal Agreement shall be submitted to legal counsel of the **City** for review and signature indicating approval as to proper form and compliance with applicable laws.
4. Pursuant to Section 11-13-209, Utah Code Annotated, 1953 as amended, a duly executed original counterpart of said Interlocal Agreement shall be filed immediately with the keeper of records of the **City**.
5. Pursuant to Section 11-13-219(3)(c)(ii), Utah Code Annotated, 1953 as amended, this Resolution and the Interlocal Agreement shall be available at the principal place of business of the **City**, located at 1020 East Pioneer Road, Draper, Utah 84020, during regular business hours for 30 days after the publication of the notice, if any, of this Resolution and/or the Interlocal Agreement pursuant to Section 11-13-219.

6. This Resolution shall become effective immediately.
