

DRAPER CITY RESOLUTION NO. 16-74

A RESOLUTION OF THE DRAPER CITY COUNCIL AUTHORIZING THE EXECUTION BY THE MAYOR OF AN INTERLOCAL AGREEMENT BETWEEN DRAPER CITY AND SANDY CITY FOR A MULTI-AGENCY SWAT TEAM

WHEREAS, Draper City and Sandy City each have legal authority to provide police services within their respective jurisdictions and otherwise as allowed by law.

WHEREAS, the Draper City Police Department (“**DPD**”) is fully equipped and functional, and has provided police services within Draper City’s geographical boundaries since its formation on 2003. Draper has a number of SWAT-trained officers, but not enough for a fully functional SWAT team.

WHEREAS, the Sandy City Police Department (“**SPD**”) is fully equipped and functional, and has provided police services within Sandy’s geographical boundaries since its formation. SPD has a fully staffed, functional SWAT team consisting of Sandy police officers.

WHEREAS, the Parties now desire to collaborate with each other to provide an integrated SWAT Team to provide SWAT services to each city.

WHEREAS, the Parties have determined that it is mutually advantageous to enter into this Interlocal Agreement, in part because doing so is expected to provide enhanced efficiencies and economies of scale to each Party’s police department.

WHEREAS, the City Attorney has reviewed the Interlocal Agreement and has approved it as to form and compliance with the Utah Interlocal Cooperation Act.

WHEREAS, the City Council has determined the Interlocal Agreement to be in the best interest of the City and will be beneficial to the health, safety and welfare of citizens of the City; and

WHEREAS, the Mayor is authorized to execute agreements.

NOW, THEREFORE, BE IT RESOLVED by the Draper City Council as follows:

Section 1. Resolution. The Interlocal Agreement for Specified Police Services between Sandy City and Draper City, attached hereto as Exhibit A, is approved and the Mayor is authorized to sign the same.

Section 2. Effective Date. This Resolution shall become effective immediately upon passage.
