

ORDINANCE NO. 1275

**AN ORDINANCE OF THE DRAPER CITY COUNCIL AMENDING
CHAPTER 2-3 OF THE DRAPER CITY CODE PERTAINING TO
THE CITY MANAGER'S CONTRACT SIGNING AUTHORITY**

WHEREAS, the Draper City Council has delegated to the City Manager authority to sign contracts on behalf of the City; and

WHEREAS, the Draper City Council wishes to expand the City Manager's signing authority to include contracts that do not involve the expenditure of city funds; and,

WHEREAS, expanding the City Manager's signing authority will assist in the orderly administration of the city's day-to-day operations; and,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF DRAPER CITY, STATE OF UTAH, AS FOLLOWS:

Section 1. Approval. The City Council hereby amends Chapters 2-3 of the Draper City Municipal Code to read as shown in Exhibit "A" which is attached hereto and incorporated herein by reference.


Section 2. Severability. If any section, part, or provision of this Ordinance is held invalid, or unenforceable, such invalidity or unenforceability shall not affect any other portion of this Ordinance, and all sections, parts, and provisions of this Ordinance shall be severable..

Section 3. Effective Date. This ordinance shall become effective immediately upon publication or posting or 30 days after final passage, whichever is closer to the date of final passage.

EXHIBIT A

Section 2-3-080 Duties, Control and Discretion.

(c) Specific Duties. Subject to the limits set forth herein, the following duties and the authority to perform them are hereby delegated to the City Manager.

(4) Signature Authority. The City Manager shall have the authority to sign all contracts on behalf of the City provided:

(i) The contract has been approved by the City Council, ~~or~~ funds to be spent under the contract have been specifically appropriated through the City's budget process, or the contract does not require the expenditure of City funds; and

(ii) The contract does not involve the conveyance of any real property interest of the City.
