

RESOLUTION NO. 18-27

A RESOLUTION AMENDING SECTION 3.2 OF THE PLANNING COMMISSION BYLAWS AND RULES OF PROCEDURE REGARDING REGULAR MEETINGS AND STUDY SESSIONS

WHEREAS, the Draper City Council approves the Planning Commission Bylaws and Rules of Procedure (“Bylaws”); and

WHEREAS, section 3.2 of the current Bylaws requires the Planning Commission to have a study session immediately before its regular meeting. The purpose of the study session being to discuss items on the business agenda; and

WHEREAS, the current practice of the Planning Commission is to schedule ½ hour for the study session; and

WHEREAS, the study session rarely take more than a few minutes as the Planning Commission cannot discuss the merits of particular agenda items leading to almost a ½ hour of wasted time; and

WHEREAS, the Planning Commission wishes to use its time more efficiently by eliminating the study session requirement in the Bylaws and address any agenda questions at the start of the business meeting.


