

RESOLUTION NO. 14-57

A RESOLUTION AMENDING THE CONSOLIDATED FEE SCHEDULE OF DRAPER CITY REGARDING APPEALS AND VARIANCE HEARING OFFICER, COPIES OF HOUSE PLANS AND ZONE CHANGE APPLICATION FEES.

WHEREAS, the Mayor and City Council wish to update certain fees shown in the Draper City Consolidated Fee Schedule to better recover the cost of providing the related services; and


Section 3. Effective Date. This Resolution shall become effective immediately upon its passage.
