

A RESOLUTION OF THE DRAPER CITY COUNCIL AMENDING THE CONSOLIDATED FEE SCHEDULE OF DRAPER CITY REGARDING PARK USAGE FEES, TRAIL EVENT USAGE FEES, AMPHITHEATER RENTAL FEES AND DAY BARN FEES AND RENTAL RETRACTIONS.

WHEREAS, the Mayor and City Council wish to update the Park and Recreation fees shown in the Draper City Consolidated Fee Schedule to be more specific regarding actual costs to Draper City, as well as implementing new user fees for events and rentals held on Draper City trails and new rental fees for the new Day Barn and The Amphitheater.

WHEREAS, the Council of Draper City finds it in the best interest of the City to protect City owned assets as well as re-coop actual costs of repair/maintenance/wear caused by participants of outside agency events; and,

WHEREAS, the City Council wishes to establish a fair and equal user fee for "exclusive use" rights to rent a publicly owned facility in Draper: and,

WHEREAS, the City Council hereby finds this action in the best interest of the public's health, safety and general welfare.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF DRAPER CITY, STATE OF UTAH, AS FOLLOWS:

Section 1. Approval. The City Council hereby amends the Draper City Consolidated Fee Schedule as shown in Exhibit "A" attached hereto and incorporated herein by reference.



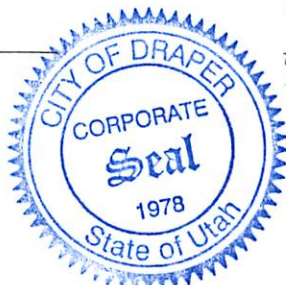
Section 3. Effective Date. This Resolution shall become effective upon adoption.

16. EQUESTRIAN ARENA RESERVATIONS (Res. 12-12)

- A) Arena Reservation Fee (Events charging no admission)
 - (i) Day Show —9 am-10 pm ----- \$200.00 plus \$100 clean-up deposit (\$10.00 non-refundable)
 - (ii) Daily charge for use of arena lights ----- \$15.00
- B) Groups Charging an Admission Fee-----300.00 per day plus \$100 clean-up deposit
- C) Arena Reservation Fee - Draper City Residents All - Youth/Adult Equestrian (less than 4 hours)-----No Charge
- D) Arena Reservation Fee – Non-Draper City Residents Youth/Adult (less than 4 hours) ----- \$20 per hour

25. PARK RESERVATIONS

(Res. 05-51, Res. 12-12)

- A) Pavilion - ½ day*
 - (i) Resident ----- \$30.00
 - (ii) Non-Resident ----- \$50.00
 - (iii) Cleaning Deposit (to be refunded upon inspection of pavilion) ----- \$25.00
- B) Non-City/Outside Agency Field rentals (ball diamonds, soccer fields, etc.)
 - (i) Resident ----- \$10.00 per hour or \$70.00 per day, per field (9am – 9 pm daylight hours)
 - (ii) Non-Res ----- \$12.00 per hour or \$85.00 per day, per field (9am – 9 pm daylight hours)
 - (iii) Per Player fee: (for large agencies or leagues who rent for a defined season on a recurring basis:
 - (a) Resident ----- \$5.00
 - (b) Non-resident ----- \$7.00
 - (iv) Lights at all parks ----- \$25.00 per hour
 - (v) City staff ball diamond prep, soccer paint/set up ----- \$25.00 per field
 - (vi) City-sponsored programs and events in co-operation with Draper Parks and Recreation - No charge
 - (vii) Upon Director approval, park rental fee may be waived on conditions of Draper City and/or its programs being able to use renters' facilities free of charge or at a comparable rate.
- C) Business Pavilion - ½ day*
 - (i) Located in the City----- \$30.00
 - (ii) Located outside the City ----- \$50.00
- D) Historic Park - Pavilion and Park Rental per event
 - (i) Per event (1 event per day max)----- \$250.00
 - (ii) Cleaning Deposit (to be refunded upon inspection of pavilion) ----- \$100.00

* For All Day Use - Double the Listed Cost

E) TRAIL USE FEES FOR SPECIAL EVENTS (OUTSIDE AGENCIES)

- (i) Trail Event use fee (per event)----- \$200.00
- (ii) Trail Event use security deposit (refundable)----- \$200.00
- (iii) Participant Fee - Corner Canyon and primitive trails (to be collected after event based on total # of participants)
 - a) More than 100 participants----- \$5.00 per participant
 - b) 100 or fewer participants ----- \$2.00 per participant
- (iv) Participant Fee – Asphalt/paved trail use----- \$2.00 per participant
(to be collected after event based on total # of participants)

F) AMPHITHEATER FEES

Amphitheater Rentals cannot charge an admission. Rentals are for a total of 4 hours each.

- (i) Tier #1 (under 200 users, front of stage and seating area only)-----\$80.00
- (ii) Tier #2 (201-500 users, includes inside of stage, restrooms, house sound, seating area)-----\$200.00
- (iii) Tier #3 (501-2000 users, includes i & ii plus use of house lights and dressing/green rooms)-\$450.00

G) DAY BARN RENTAL FEES

Rental blocks will be available for 2 time blocks, 9am-3pm or 4pm-10pm. Rentals include use of building, restrooms, 12 66" circular tables, 96 chairs and 2 6ft banquet tables.

- (i) Rental rate per each block for RESIDENT/DRAPER BUSINESS -----\$150.00
- (ii) Rental rate per each block for NON-RESIDENT/NON-DRAPER BUSINESS-----\$200.00
- (iii) Security Deposit per rental (refundable)-----\$200.00
